## Representative Dean Sanpei





### **Should Sales Tax Be Increased?**



Our district overwhelmingly opposed the proposed increase in the sales tax on food. As the figure above shows, nearly 80% say they do not support this recommendation. I along with most members of the House opposed the tax and it did not pass during the 2013 session.

### **How to use Excess Funds**



Education is consistently the most important priority for our district. During the 2013 session we were able to balance the budget, but also fully fund growth in public education at \$75 million, increase the weighted pupil unit 2% at \$48 million. We also added more than \$23 million in additional funding to higher education.

## **Establishment of Independent Ethics Commission**

Representative Sanpei was the House Sponsor for the establishment of an Independent Ethics Commission for the Executive Branch. Somewhat surprisingly the 5 constitutional officers in the executive branch (Governor, Lt. Governor, Auditor, Treasurer, and Attorney General) have had provisions to deal with criminal conduct, but they have not had provisions to deal with unethical conduct.

While criminal behavior is always unethical the reverse is not always true – unethical conduct is not always criminal. Through the legislation sponsored by representative Sanpei in the House provisions for dealing with unethical conduct have been established for elected officers in the executive branch. The commission has the power of subpoena, investigation, and can refer facts with merit to impeachment proceedings, or it can hold information private in instances where no merit to the claims is found.
