Major Legislative Activity

**Balanced Budget** - 2013 total budget was set at \$13 billion. The structural deficit has been reduced from \$313 in 2010 down to \$52 million in 2012. Taxes have not been raised. Total state debt has been reduced by about \$130 million.

**Medicaid Reform** - Representative Sanpei has been one of the most active and critical participants in Medicaid reform. He sponsored and passed legislation in 2012 that continues to facilitate the reforming of medicaid payment mechanisms in Utah. Those efforts along with ones that Representative Sanpei participated in heavily in 2011, are estimated to save Utah over \$770 million over 7 years increasing further over time.




## Severance Tax Trust Fund

This is an important issue that will be on the November ballot as it is a constitutional amendment. The legislature voted to gradually allocate severance tax revenues (which are generated from nonrenewable sources such as oil and natural gas) into a permanent trust fund. The challenge is that this will create tens of millions in short term shortfalls in the state budget. The good news is

that this will ensure future generations will always have access to this source of funding and within approximately15 years the interest generated from the trust fund will exceed the annual amounts Utah is spending today.

# Education

In every survey conducted in District 63 - education rises to the very top of the priority list. The 2012 legislature found a way to fund K-12 public education higher than the governor asked and also funded the growth of new students in the system.
